- 1. Revision and operationalisation of national disaster plan, including training of key officials and outer island officials
- Preparation and implementation of disaster awareness programmes for the general public and for inclusion in the school curriculum
- 3. Assessment of hazards and vulnerabilities and consideration of these assessments in the national development planning

2. Present national plan for natural disaster reduction

The Disaster Plan is included in the General Administrative Order; a workshop held in 1991, recommended updating of this plan; these recommendations are not yet implemented

No specific disaster mitigation activities have been carried out to date

No specific projects have yet been formulated to address disater reduction in Tuvalu. Improvement of the institutional structure and arrangements will provide the basis for the formulation of such projects. Institutional strengthening, training and updating of disaster plans are therefore the first priorities. Other priorities identified include:

- Preparation and implementation of disaster awareness programmes for the general public and for inclusion in the school curriculum
- Assessment of hazards and vulnerabilities and consideration of these assessments in the national development planning
- Operationalisation of the National Building Code [the code has been prepared, but the legal framework for enforcement is not yet operational1

1. Overall evaluation of national disaster mitigation programmes including, but not limited to, those initiated after IDNDR and achievements up to now

National disaster programmes are at present largely focused on disaster relief and rehabilitation. The institutional capacities to develop and implement pre-disaster programmes have not yet been sufficiently developed.

2. Review of the IDNDR

IDNDR has not played a significant role in the disaster programmes of Tuvalu. It would be beneficial to the country if the IDNDR infrastructure is used to strengthen our cause. We see opportunities for this in three directions.

Firstly, IDNDR should play an increasing role within the South Pacific, in particular in raising awareness of the opportunities to reduce the toll of natural disasters and thus contribute to a shift from disaster relief to disaster mitigation and preparedness. Secondly, it is hoped that through the activities in IDNDR, Tuvalu will gain increased access to technological and scientific information that can contribute to risk reduction. And thirdly, through the activities and meetings in IDNDR, the international community may increase its understanding and appreciation of the characteristics and vulnerabilities of atoll countries and the impact disasters can have on sustainable development in the region. It is hoped that this may initiate further cooperation in efforts to reduce disasters in the region.
