Disaster and Disaster Management in Sri Lanka

- ❑ Sri Lanka has been suffering from varieties of disasters
 - ❑ The disaster occurrence trend has been dramatically increased in the recent past
 - ❑ Large numbers of people in scattered geographical areas are affected,
 - ❑ Huge amount of development gains are being lost

Institutions, Legal System and Initiatives

- ❑ Disaster Management Act enacted in 2005
 - ❑ National Council for Disaster Management was established in 2005
 - ❑ DMC was established in 2005
 - ❑ MDM&HR was established in 2006
 - ❑ Road Map for Disaster Risk Management “Towards a Safer Sri Lanka” was developed in 2006
 - ❑ Policy on DM and National DM Plan developed awaiting approval
-

Opportunities

- ❑ Since 2003 floods and landslides, several INGOs/ NGOs/ CBOs and GOs are working in different aspects of DM in the country mostly on Relief and response activities
- ❑ Several donors and UN agencies have been supporting DRM activities and expressed interest to support in the days to come
- ❑ There are more disaster prone areas to be covered by programme and ample opportunities to link disaster with development.

continue..

- Little or No information at national level on **WHO is DOING WHAT?**
 - Less information on **mainstreaming DRR** into development activities and the **linkages**
 - Ample opportunities to **'replicate' successful initiatives**, and understand what approaches work most effectively, under what conditions. Also opportunities to learn from neighbouring countries.

Challenges

- ❑ Large number of GOs/ INGOs/ NGOs/ CBOs are working in DRM in different parts of the country
 - ❑ In many cases organizations are working in isolation and competing for resources
 - ❑ Duplication of activities
 - ❑ Organizations interested to work in accessible, close by and district hqs
 - ❑ National level “**DRR Movement**” cannot be done without the active participation of ALL actors in the country

Way forward for better COORDINATION

- ❑ Since 2004 tsunami, several rounds of meetings and information exchange among DM actors going on at different levels
 - ❑ UN agencies and DMC jointly organized Inter Agency Steering Committee (IASC) on DRM in November 2006,
 - ❑ **National Advisory Committee** on DM Chaired by the Minister DM&HR and **Inter-Ministerial Coordinating Committee** Chaired by Secretary M/DM&HR has established an effective coordination mechanism in state sector agencies
-

Way forward for better COORDINATION

Continue..

- ❑ DMC/UNDP/ISDR organized National level meeting on April 2007 and endorsed by all to establish a national coordination mechanism
 - ❑ On 25 May 2007 in a national forum all participants agreed to form a national mechanism under the leadership of Secretary, MDM&HR

Way forward for better COORDINATION Continue..

- A National DM Coordination Committee (NDMCC) is in process to form with representative from GOs, Donors, UN agencies, INGO, NGOs, Media, Academic institutions, Private Companies and CBOs under the leadership of the Secretary, MDM&HR
 - NDMCC will be developing its ToR to facilitate the national level coordination mechanism.

Way forward for better COORDINATION

Continue..

- Possibility of merging National DM Coordination Committee with the Inter-ministerial Coordinating Committee Chaired by the Secretary M/DM&HR is under consideration

- Contribute to the national efforts to **reduce the impact of disasters,** and **build disaster resilient communities**

Objectives of the NDMCC

Objectives

- To provide a **FORUM** for DM actors to **exchange and share information,**
 - To facilitate the **documentation of good practices** and **lessons learned** on DRR,
 - To **influence national policy** in a more effective manner,
 - Better **COORDINATION** among **ALL DRM actors** for successful implementation of the “Road Map for Disaster Risk Management: Towards a Safer Sri Lanka” and avoid duplication
