FREQUENTLY ASKED QUESTIONS

How do I participate in the dialogues?

Participating is easy. Simply create an account and log in to the dialogue to get started: http://www.preventionweb.net/posthfa/dialogue/

Each dialogue is structured around a set of questions. Each set will be open for a period of two weeks.

Can I post in other languages?

Yes. We encourage posting in any language and provide a Google Translate option.

Simply select the language you wish to view.

How can I contact the facilitator?

You can send a private message to the facilitator by clicking the facilitator's name, and then click the link to send him/her a message.

How can I contact other participants?

You can send an individual a private message, or start a private conversation with one or more participants.

To send a private message, click the participant's name, and then click the link to send him/her a message.

To start a private conversation with one or more participants, go to "My Inbox" and click "start a conversation." Start typing a participant's name to add him/her to the conversation.

How do I get discussion updates by email?

First, log in. Once logged in to a dialogue, you can subscribe to individual questions within a discussion.

First, click the name of the discussion, e.g. "Setting the context".

You will see each question with a star at the right:



Click the star to subscribe to each individual question. The star becomes yellow:



You will now receive an email each time a new post is made. A daily digest is coming soon.

Who can see my posts?

The dialogue is open for all to see. To contribute, you must log in to post.

Can I attach additional information?

You can add links to online information (documents, videos, websites, etc.) in your posts. You cannot upload attachments.

Where can I edit my profile and upload a photo?

Simply click your name, then "My Profile."
