SEECP – Bulgarian CiO Ministerial Meeting on Disaster Preparedness and Prevention Sofia, 9 April 2008 Concept Paper and Draft Agenda

Background

Regional co-operation in the field of Disaster Preparedness and Prevention (DPP) is a vital topic for South Eastern Europe (SEE) for a variety of reasons including the exposure of the region to a range of natural disasters (earthquakes, floods, fires etc) and the need to reduce the vulnerability of relatively weak economies to the impact of such disasters.

A number of initiatives are underway or are being developed to tackle different aspects of DPP - so called "soft measures" (e.g. capacity building, training, institutional co-operation) and financial measures – financing physical investments and the development of a comprehensive but affordable risk insurance framework for governments, businesses and households.

Successful implementation of these initiatives requires high-level political commitment from the countries of the region and the international community.

Overall Objective of the Ministerial Meeting

SEECP Ministers will adopt a Ministerial Statement on DPP that will commit the parties to action in specific areas within a defined time period. This will include a commitment to developing a regional co-operation strategy for DPP. The Statement will be based on the commitments already made by countries of the region under the Memorandum of Understanding on the DPP Initiative of the Stability Pact for South Eastern Europe.

This Ministerial Statement will be supported by senior representatives of the international community who are active in the area of DPP including the EC, World Bank, NATO and UN - ISDR and OCHA.

Format and Participants

The one-day Ministerial meeting would take place in Sofia on 9 April under the chairmanship of the Government of Bulgaria. Participants will include the responsible ministers and senior officials from the SEECP Participating States and the international community.

Speeches/interventions at the meeting would be organised along specific topics (see attached draft agenda). Speakers would comprise relevant ministers of the SEECP participating states, the EU Presidency, the EC, World Bank, NATO, the UN (ISDR and OCHA) and the Regional Co-operation Council. The meeting would conclude with the formal adoption of the Ministerial Statement on DPP in SEE.

The ministerial meeting would be preceded (the day before) by the Regional Meeting of the SP's DPPI initiative. Additional preparatory meetings on issues such as risk mitigation for DPPI may also take place.
