
Disaster Risk Management (DRM) Workshop, Dhaka, Bangladesh

Purpose of Workshop

The purpose of the DRM workshop is :

• To provide practical skills for Humanitarian/Relief practitioners who are involved in the Risk Reduction, Emergency Response and/or Recovery Initiatives in Disaster Risk Management (DRM) situations

The workshop will look at global best practice in both DRM and the development and implementation of Disaster Risk Management Plans. This training is aimed at governmental, non-government organisation (NGO), Red Cross, UN and other stakeholder personnel. It will draw down on lessons learnt from both Bangladesh (eg the 2007 Cyclone Sidr) and other Asian (eg the 2004 Indian Ocean Tsunami; 2008 Myanmar Cyclone Nargis) major hazards and disasters.

Who is this course for?

This workshop is primarily designed for people across the humanitarian to development spectrum. In previous workshops, participants have come from the following:

- Non-Profit Organisations (NGOs), and Community Based Organisations (CBOs)
- Government departments or government-funded bodies
- UN agencies and bilateral funding agencies
- Australian/International Management Contractors (AMC/IMCs)
- Tertiary Institutions and Individuals (Volunteers, Consultants, Students)

Previous DRM workshops held in Dhaka during 2006 & 2007 saw participants coming from India, Nepal, Indonesia, Afghanistan, Australia as well as, of course, Bangladesh

Skills Taught/ Methodology

The range of practical skills required to prepare practitioners for DRM initiatives will be introduced using a combination of adult teaching methodologies. There will be a strong emphasis on Risk Reduction, although lessons learnt from the Emergency Response and Recovery stages of major disasters will also be covered. A field visit will take place on Day 3 to illustrate the various DRM initiatives being undertaken at various levels along the River Jamuna to deal with the risk of flooding, river erosion and other hazards.


