

The objective of WBI's Natural Disaster Risk Management Program (NDRMP) is to promote proactive disaster risk management practices by raising awareness among key stakeholders and by advancing the analytical skills and professional knowledge of development practitioners in specific areas of disaster risk management.

The NDRMP is a combination of global, regional and country focus activities consisting of: (i) training programs: comprehensive and specialized courses to meet the learning needs of key players in disaster risk management; (ii) policy services to build consensus and raise awareness in proactive disaster risk management practices; and (iii) knowledge sharing and knowledge exchange activities to promote horizontal learning.

The NDRMP provides training and learning opportunities on global scale reaching out and connecting development practitioners involved in disaster risk reduction. The courses have been localized to the Philippine setting.

Learning through the Internet

The NDRMP jointly offered by WBI, NDCC and EMI consists of a series of training courses eLearning that participants go through over a certain time period. eLearning refers to the use computer-based electronic of technologies of Internet, e-mail, websites and CD-ROMs, and their applications, to deliver, facilitate and enhance both formal and informal learning and knowledge sharing at any time, any place and at any pace. A facilitator is assigned for each participant to provide learning guidelines and monitor learning progress. Certificates of completion will be awarded by WBI.

Who may join

Policy-makers and their technical staff: current laws and polices on disaster management need to be reexamined in the light of disaster risks from natural hazards.

Urban and land use planners: cities are the most vulnerable given the density of its population and the continuing construction of homes and buildings that are at risk if land use plans are not updated and validated.

Construction professionals: architects, engineers and other practitioners involved in real estate development need to incorporate disaster risk reduction into their work plans so as to avert the collapse of buildings and structures.

NGO/PO/CSO Workers: community leaders who are active in the prevention of disaster risks in their locality must be able to reestablish themselves when disasters strike.
