Co-ordination of Disaster Management activities of national level is carried out by Inter-Ministerial Disaster Management Co-ordination Committee IMDMCC headed by the Minister for Relief. The Ministry is assisted by Disaster Management Bureau (DMB) and Department of Relief and Rehabilitation. In the field, District Disaster Management Committee, Thana Disaster Management Committee and Union Disaster Management Committee performs disaster preparedness work and disaster management co-ordination functions.

# 1. Steps towards achieving the 3 main Decade targets

- (a) Comprehensive national assessments of risks from natural hazards, with these assessments taken into account in development plans;
  - The National Disaster Management Council (NDMC) gives policy guidance on resource allocation and priorities of disaster mitigation project in the National Development Plan.
  - The National IDNDR Committee also deliberates on mitigation measures and makes recommendations to NDMC.
  - A Committee has been constituted at the Planning Ministry, with Minister for Planning in the Chair, for Co-ordination disaster of disaster mitigation projects included in the Annual Development Programme (ADP).
- (b) Mitigation plans at national and/or local levels, involving long-term prevention and preparedness and community awareness; and
  - A massive programme of Afforestation in the cyclone prone area has been undertaken with World Bank assistance. ADB is also likely to support another afforestation programme. A feasibility study has been done (July-November 1993)
  - 26 studies has been undertaken for Flood Action Plan
  - A programme of construction of 2,000 shelters have been undertaken. Some are already completed some under construction and assistance for rest is awaited.
  - Telecom, Road Communication and Communication to offshore islands are being developed.
- (c) Ready access to global, regional and local warning system and broad dissemination of warning.
  - (i) Satellite communication facilities are available for cyclone warning but own facility is yet to be developed.
  - (ii) Regional weather infirmations are available in limited scale.
  - (iii) National cyclone warning radars can detect cyclone in Bay of Bengal (450km).
  - (iv) Cyclone warning dissemination facility through (TV, Radio media and Telephone etc.) is satisfactory.
  - (v) 26000 volunteers of Cyclone Preparedness Programme (CPP) disseminate cyclone warnings at village level in the cyclone prone area (coastal districts).

Previously there was no central Organisation to Co-ordinate disaster management activities/project. The Ministry of Relief however worked as focal point for disaster management. In May 1993 the government of Bangladesh has established a new organisation named Disaster Management Bureau, which will co-ordinate all Disaster Management Activities in Bangladesh. Moreover the following Committees set up during 1992 and 1993 are working towards achieving the IDNDR objectives:

- a) National IDNDR Committee (Chairman: Minister for Relief)
- b) National Disaster Management Council (Chairperson: Prime Minister)
- c) Inter-ministerial Disaster Management Co-ordination Committee (Chairman: Minister for Relief)
- d) Committee for Coordinating Disaster Mitigation Projets (Chairman: Minister for Planning)
- e) District Disaster Management Committee (Chairman: Deputy Commissioner)
- f) Thana Disaster Management Committee (Chairman Thana Executive Officer)
- g) Union Disaster Management Committee (Chairman: Union Council Chairman)
- h) National IDNDR Committee was formed (Chairman: Minister for Relief)
- i) District and Thana IDNDR Committee was formed (Chairman: Deputy Commissioner and TNO)


