

# Hyogo Framework for Action: 5 priorities Local adapation


- Make DRR a priority: Ensure that reducing disaster risk is a national and local priority with a strong institutional basis for implementation
- 2. Know the risks and take action: Identify, assess and monitor disaster risk -urban risk assessments- and ensure early warning
- 3. Build understanding and awareness: Use knowledge, innovation and education to build a culture of safety and resilience at all levels PARTICIPATION
- 4. Reduce risk: Reduce underlying risk factors- PLAN AND ENFORCE
- 5. Be prepared and ready to act: Strengthen disaster preparedness for effective response at all levels

#### Average score of progress



## Reviewing progress in disaster risk reduction: the 2011-2013 process of monitoring HFA progress at local, national and regional levels








- If disasters don't occur, then DRR builds capability. (no regrets)

# Over 50% of world population live in urban settlements


#### Prediction for 2030: 2 billon new urban habitants

#### **Ten-Point Checklist - Essentials for Making Cities Resilient**



1. Put in place organization & coordination to clarify everyone's roles & responsibilities.



2. Assign a budget & provide incentives for homeowners, low-income families, private sector to invest in risk reduction.



3. Update data on hazards & vulnerabilities, prepare &



4. Invest in & maintain critical infrastructure, such as storm drainage.



**5.** Assess the **safety of all schools and health facilities** & upgrade these as necessary.

The campaign urges individuals or organizations to make a commitment to do specific actions on any of the three components that could make schools and hospitals safer before a disaster:

- ✓ Public awareness,
- ✓ Emergency and disaster preparedness, and
- ✓ Disaster risk reduction



- ✓ To make people aware about safe schools and hospitals
- ✓ To be prepared in case of emergencies and disasters
- ✓ To contribute time, effort or resources to make schools and hospitals safer



6. Enforce risk-compliant building regulations & land use planning principles, identify safe land for low-income citizens.



7. Ensure education programmes & training on disaster risk reduction are in place in schools and local communities.



8. Protect ecosystems & natural buffers to mitigate hazards, adapt to climate change.



9. Install early warning systems & emergency management capacities.



10. After any disaster, ensure that the needs of the affected population are at the centre of reconstruction.

## Leadership in the campaign

- •"Participating Cities": Working in the field of disaster risk reduction and committing to implement at least one of the 10 essentials.
- •"Champions": Mayors, other local leaders, or Public figures, promoting the campaign and engaging other local governments.
- •"Role Models": Local Governments that can demonstrate achievements in at least 5 of the 10 essentials; willingness to share their experience with other local governments.

# Thematic Platform on Urban Risk for the Americas


- 1st presented by the City of Bogota, Colombia, during Global Platform for Disaster Risk Reduction in 2007.
- Platform evolved to a network of local governments throughout the region focusing on strengthening their capacities for the incorporation of disaster risk management in urban planning and development.
- The platform provides a space to discuss common problems, exchange experiences and knowledge, and to strengthen urban risk management processes for participating cities.
- It further promotes initiatives for cooperation between cities and other strategic partners for the implementation of risk reduction practices based on existing tools such as the Hyogo Framework for Action and sustainable development policies.

Complement the national HFA monitoring and multi-stakeholder engagement process by providing information and an assessment of the situation from the local level on a voluntary basis.
