

## The UNISDR Pacific Innovation & Leadership Award for Resilience 2014

Recognizing innovative sustainable disaster risk reduction in the Pacific

# PILAR (2014)

To mark the approaching 10<sup>th</sup> anniversary of the Hyogo Framework for Action. the inaugural Pacific Innovation & Leadership Award for Resilience (PILAR) is being launched to recognize innovative **Pacific** examples of disaster risk reduction initiatives in the last 12 months that overall contribute to building the resilience of nations. and communities to the risks of disasters, enabling them to thrive sustainably.

For the first time in the Pacific. the United Nations Office for Disaster Risk Reduction will recognize an individual, organization, business. government, or NGO with the annual award. The winner will be announced and award presented at the 2014 Pacific Platform for

Fiji on 2 June 2014.

Applications will be assessed by a panel of regional experts and specialists. **Submissions** are required to address at least one of 5. Engaging the following focus areas:

- 1. Enhancing people's awareness of their vulnerability to disaster;
- 2. Conveying new insights knowledge the larger community on how to build resilience to disaster:
- 3. Engaging the larger community in activities – economic, financial, legal, educational, social or cultural - that help strengthen society's preparedness against disaster:

- Disaster Risk Management in Suva, 4. Making clear proposals and recommendations influence disaster risk reduction policy based on evidence:
  - other essential activities recognized promoting disaster mitigation and building disaster resilience, warning, such as early education similar activities.



Special consideration given to submissions that

#### Demonstrate innovative approaches to:

- o 'First Ever' premiere actions within a network or community; or
- o Triggering new types of partnerships; or
- New uses of technology in ways rarely seen before; or
- o "Breakthrough" ideas; or
- Being credited as influential by peers or the community



#### Has wide outreach and impact relating to:

- Behaviour change within community; or
- Impact on people in varied settings civil (government, society, education, scientific and private sector community); or
- Triggering successful partnerships; or
- o Far reaching outcomes not just locally but nationally, region-wide or globally



### Submissions for the 2014 PILAR are required to:

- ✓ Be Pacific based activities\*
- ✓ Address one of the five focus areas described above:
- ✓ Show innovation and/or have had a demonstrated impact on building resiliency (accomplished within the last 12 months (April 2013 – April 2014);
- ✓ Complete attached 2 page application form;
- ✓ Application received by UNISDR by COB 15<sup>th</sup> May 2014.
