Population (year)	Its population is about 1.1 million inhabitants (INE, 2008), however, the fluctuating population in Maputo becomes higher during the day, considering the metropolitan area links, like work, school, trading, public services etc
GDP	Maputo contributes over 30 percent of the national Gross Domestic Product and is the gateway for investors, tourists and migrants from rural areas and surrounding countries. It is the most densely populated urban area in the country
Hazard type(s)	Given its geographical location over the ocean, Mozambique is recognized in Africa as one of the country's most vulnerable to extreme climate events, mainly those of origin hydro-meteorological. The main climate-related hazards with destructive consequences are floods, drought, rising sea level and storms (cyclones)

Major Disaster Risks (Please indicate major disasters that have occurred, prevailing hazards and vulnerable conditions.)	
During the last 25 years Mozambique suffered from an uninterrupted sequence of drought and floods which negatively affected the country's social and economic development. The most severe drought periods were recorded in 1981-1984, 1991-1992 and 1994-1995; while floods were observed in 1977-1978, 1985, 1988, 1999-2000 and more recently in 2007-2008. Floods are often exacerbated by cyclones. In particular, the amount of recorded during the 1999-2000 wet seasons were extraordinarily high and flooding had terrible consequences. During the months of February to March 2000 a combination of torrential rains and tropical cyclones caused the most devastating floods in the history of Mozambique killing 700 people and producing damages worth 600 million dollars

Plans – Agreement of Cooperation between UN-HABITAT and MMC, signed in April 2010, it has been developed a comprehensive Implementing Plan which basically intends to: • Perform a specific and detailed study on the socio-economic impacts of climate change in the city of Maputo focusing on vulnerable areas; • develop a Local Climate Change Adaptation/Mitigation Plan; • execute demonstrative CC adaptation/mitigation interventions at priorities urban areas and settlements of Maputo City; • create a database related to climate change events; • implement a capacity process of MMC human resources in matters related to climate change in urban areas.
