Bangkok RCC 2 Declaration on "Future Directions of Regional Cooperation and RCC", 2001

- Useful and beneficial platform for dialogue, exchange of experience and lessons learned
- An important mean of conceptualizing and developing practical cooperative programs between member countries at the regional and sub regional level
- Membership from senior officials of member countries, national disaster coordinating bodies,
- Invite officials from Ministries of Finance, Planning and Foreign affairs and key sectoral ministries
- **Encourage participation of observers from** multilateral and bilateral agencies, donors, relevant UN agencies and intergovernmental organizations
- ADPC to serve as a facilitator and convener of this mechanism as well as the regional focal point and technical resource for RCC
- Annual meetings be organized in different countries preferably with a thematic focus and opportunity to see the host country DM system

Bangkok RCC 2 Declaration

Bangkok RCC 2 Declaration of 2001 on "Future Directions for Regional Cooperation and RCC

Toenty three delegates from 16 RCC member countries and 12 observers from multi-lateral and bilateral corneiss met in Bangkok for the 2rd Meeting of the RCC. The meeting endorsed the key further directions for the Regional Cooperation in Disaster Management and for the RCC as follows:

Comprehensive Risk Management Approach

Recognizing the increasing incidence and severity of natural, technological and mammade disaster risks in Asia and the Pacific, the meeting encouraged all RCC member countries to adopt a Comprehensive Risk Management Strategy (i.e. comprehensive multi hazard disaster risk management and reduction). This strategy should cover all hazards and all phases of disaster management including presention, mitigation and preparedness in addition to response and recovers.

Key Action Areas

The meeting discussed the key action areas for the RCC to altonce the Comprehensive Risk Management approach in the coming years in 4 broad categories:

- · Building Community Level Programs for Preparedness
- Capacity Building of National Disaster Manageme Systems (See box for details)
- Cooperation with Sub-Regional Mechanisms such as ASEAN, SAARC, SOPAC, MRC and ICIMOD
- · Regional initiatives to create appareness and promote political will (See box for details)

The meeting concluded that the RCC is a very useful and beneficial platform for dialogue, exchange of experience and lessons learned. It also serves as an important means of conceptualizing and developing practical cooperative programs between member countries at the regional and sub-regional levels. The meeting recommends that the RCC chanism should be institutionalized.

2005 Hanoi Declaration on "Mainstreaming Disaster Risk Management in Development (MDRD) and Enhancing Regional Cooperation"

- "Realizing that DRR is not a stand-alone sector but an essential concern that operates at all levels and across all sectors; and that significant action is required to mainstream DRR in the process of development policy, planning and implementation"
- "Recognizing the role of National Platforms to facilitate increased stakeholder participation to serve as a base for mainstreaming of DRR"
- "Recognizing the responsibility of the RCC as a mechanism, offers to serve as a useful forum and reporting mechanism through which the progress of the implementation of the HFA can be monitored by ISDR, and advocates that the 10-year HFA framework should be broken down into 2-year milestones of accomplishments to facilitate a workable implementation of the HFA for each of the RCC Member Countries"
- "Requests ADPC in its capacity as secretariat of the RCC mechanism to continue to be the support agency of the RCC MDRD program"

- To play a greater role beyond supporting and monitoring
- To provide guidance on program in key areas such as mainstreaming DRR in development
- To encourage the implementation of the HFA within a regional context with regional HFA projects/activities/programs

RCC Expectations for the support of the Implementation of the HFA and the National Platforms from the UN-ISDR, the IATF, the UN Agencies, ADPC, the UN-ISDR IAP and the donor community

- To conduct Capacity Building programs for HFA implementation
- That the ISDR-ASIA PARTERSHIP role as catalyst be improved
- UN OCHA/UNDP/ISDR consider HFA implementation as one of the many forms of regional cooperation action through working closely with all of the partners of the UN ISDR IAP
- Assistance be provided to enhance the exchange of information, communication systems and capacity of communication and technology transfer including funding and resource mobilizations for all these activities.

RCC Expectations for the support of the Implementation of the HFA and the National Platforms from the UN-ISDR, the IATF, the UN Agencies, ADPC, the UN-ISDR IAP and the donor community

- All actors urged to meet and discuss the ways they can provide comprehensive support to the HFA Implementation
- UN-ISDR requested to assist in capacity building, to provide guidelines on the implementation of HFA
- IATF called upon to assist in capacity building in the area of response and to provide technical assistance

- The Session discussed
 - Role of RCC in context of proposed Regional Platform
 - Establishment of National Platforms in Asian countries
 - Good examples of the implementation of the HFA by National Government of the RCC Member countries

Recommendations at RCC 6 Meeting on Role of RCC in Implementation of HFA

- RCC could play a vital role in terms of periodic monitoring and evaluation in the implementation of HFA
- Provide greater assistance in information sharing by maintaining regional websites, newsletters, consolidating progress of individual countries and capturing progress in specific sectors
- RCC as a regional mechanism could play an important role in consolidating the HFA themes and reporting back the progress made in the countries and specific sectors to the Global Platform

ADPC commitments to support HFA Implementation as made at the 11th IATF in May 2005

- 1 Support to countries of the region in planning and implementation of HFA
- 2 Support to establishment of National Platforms for Disaster Reduction in interested countries
- 3 RCC program on Mainstreaming of DRR into Development
- 4 Joining with other regional agencies and regional offices of UN Agencies to develop a system of structured cooperation and technical assistance to countries of the region

Review of RCC Mechanism

- Established itself as a meaningful neutral platform among DM focal points of Asian Governments for discussion, exchange of experiences, identification of new thrust areas and learning from others
- Has helped identify new initiatives to be taken up at national level
- Catalyzed action in existing sub-regional mechanisms
- Provided opportunity for UN agencies, donors and technical institutions to understand perspectives, constraints, challenges and priorities of national government
- Increased ownership by national government and opportunity for political leaders to demonstrate support and political commitment
- Enhanced visibility for Disaster Reduction in country
- Slow but steady progress on taking up implementation on regional scale projects arising from wide-ranging agenda coupled with constraints of resources
- RCC is an existing "Regional Platform" as conceived in HFA and its annual meetings provide an opportunity for catalyzing and monitoring HFA implementation
